FINE ARTS & CRAFTS SHOW STANDARDS

- The Town of Leesburg Parks and Recreation Department is committed to presenting the highest quality vendors at our Fine Arts & Crafts Shows.
- The Town of Leesburg Fine Arts & Crafts Shows are juried. **Jurors will make their selections based on product diversity, creativity and workmanship.** Only work representative of that submitted to be juried may be exhibited; you may not sell other non-related crafts that were not juried. Examples of eligible items are: Glass, Sculpture, Fiber Art, Jewelry, Wood, Metal, Doll Fashions, Fine Art/Graphics, Photography, Body/Bath Products and Food items: dips, mixes, oils, vinegars, chocolates, jams/jellies and baked goods.
- All vendors **MUST BE PRESENT TO DISPLAY AND SELL THEIR OWN ORIGINAL** work. The artist/craftsperson who designs and creates the work is required to be at the show. Representatives, including spouses or family members may assist, but may not attend in lieu of the vendor.
- We do not allow imports, kits, items made from kits, items made using commercial patterns or commercial molds, items assembled from pre-manufactured components, commercial T-shirts or sweatshirts. The Town of Leesburg reserves the right to ask vendors who have misrepresented their merchandise to leave the show.
- All merchandise displayed must be for sale and remain at the original price for the entire show. Items cannot be marked down for quick sale, except for baked goods. No commission will be taken on sales.
- All vendors are required to collect and pay Virginia State Sales Tax of 6% on all merchandise sold. You will be sent form ST-50 to fill out and send to the Department of Taxation. Info at: www.tax.virginia.gov.
- A Temporary Food Permit is required for vendors who provide **samples** of food products (baked goods, candy, jams/jelly, dips, beverage, etc.) The permit **must** be displayed at the event. - Four (4) color photos must be included and should represent work created within the last year. Photos will be returned at the end of the last show you apply for. Photos/payments for waitlisted vendors will be returned approximately two weeks after the show.
- Vendors are invited to donate a \$10-\$15 item for a door prize.
- Vendors will be responsible for providing their own professional booth set-up. Displays should be eye appealing. Flat table top displays are discouraged: please use elements of elevation and multi-level displays. All of exhibitor's display, including chairs, must be placed within the confines of the space. **Vendors may not tape, tie, secure or hang any signs or part of their display on walls or windows.**
- Vendor booths must remain set up until the close of the show. Vendors who leave early will not be considered for any future shows sponsored by the Town of Leesburg for one year. Vendors must remove all trash from their booths at the end of the show.
- Booth placement will be based on special need requirements, variety of crafts, postmarks, and vendor preferences. See layout and booth size diagrams on Photo Description page. Space requests will be considered but are not guaranteed.
- **Indemnification.** Exhibitor and/or Vendor agrees to indemnify, defend and hold harmless the Town, its officers, agents, and employees from any claims, damages and actions of any kind or nature, whether at law or in equity, arising from or caused by any services/operations of any kind or nature furnished by the Exhibitor and/or Vendor. Vendor acknowledges that it is responsible for any personal injuries or property damage that may occur during the event for any reason and that the Town will not insure the Vendor for any risks associated with the event.
- Town of Leesburg will not be liable for refunds or any other liabilities whatsoever for the failure to fulfill this contract due to the reasons of the enclosure in which the event is held, being before or during the show, is destroyed by fire, or other calamity, or act of God, public enemy, strikes, statutes, ordinances, or legal authority or any other act beyond the control of the Town of Leesburg that make it impossible or impractical to hold the festival. The Town of Leesburg will not be liable for any damage done by vendors to public/private property during set-up, tear down and regular operation hours. This includes the operation of any equipment (motorized or non-motorized.)

3. Label the four photos with your name.

From Frederick, MD and points North

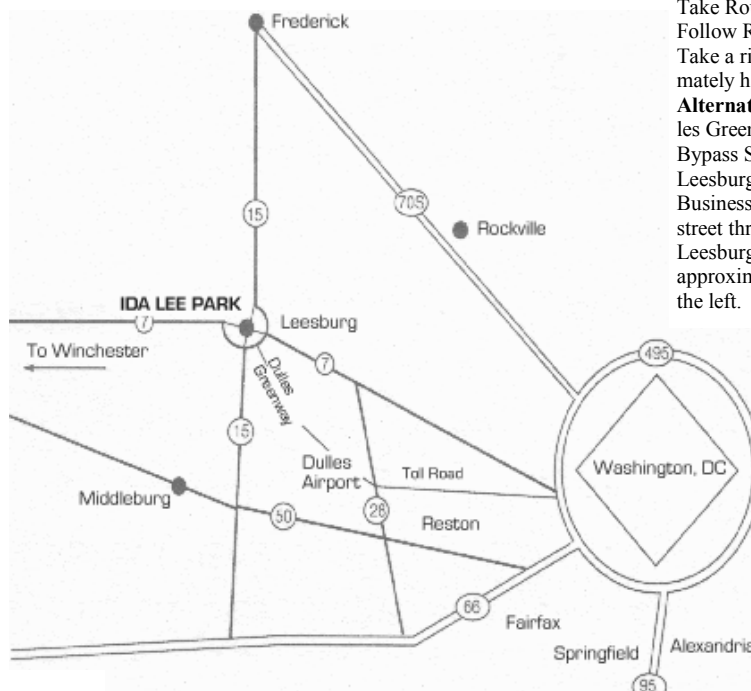
Take Rt. 15 south to Leesburg. Stay on Rt. 15 Business South (King Street) towards the downtown area. Park entrance is on the right.

From Winchester and points West

Take Route 7 east to Leesburg exit. Follow Route 7 Business (Market Street.) Turn left at King Street. Go about half-mile to park entrance on the left.

From points South

Take Rt. 15 north to Leesburg. Stay on Rt. 15 straight into historic downtown (King Street). After crossing Market Street go approximately half-mile to park entrance on the left.



From points East

Take Route 7 west towards Leesburg. Follow Route 7 into town (Market Street). Take a right onto King Street. Go approximately half-mile to park entrance on the left.
Alternate Route: Take Dulles Toll & Dulles Greenway (Rt. 267 West) to Rt. 15 / Rt. 7 Bypass South towards Winchester / Leesburg. Take the first exit for Leesburg 15 Business North (King Street). Take King street through the historic district of Leesburg. After crossing Market Street go approximately half-mile to park entrance on the left.
